The Colonie Police Department has informed us that a sex offender is now living in Latham area. Attached is a community notification report that provides historical and personal data about the offender.

This report is issued for the purpose of alerting you to the presence of a sexual offender who may pose a public risk.

Certainly the report speaks for itself. We urge you to speak to your children about how they should react to anyone who inappropriately approaches them. We will continue to be vigilant at school and alert all staff members.

The Town of Colonie Sex Offender Notification Report is available in each of the school offices, Transportation Department Office and the Central Administration Office should you wish to access additional information. The Colonie Police Department urges its residents to access these available resources for the most up to date information regarding sex offenders.
